These financial results have been reviewed by the Audit Committee at its meeting held on 10th November, 2020 and approved by the Board of Directors of the Company at its meeting held on 11th November, 2020 through Video Conferencing (VC).

(4) The Statutory Auditors of the Company have carried out Limited Review of the above Unaudited Financial Results in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations.

(5) The Company has considered the possible impact that may arise from CoVID-19, a global pandemic, on the carrying amount of its assets including Property, Plant and Equipment, Inventory and Receivables. In developing the assumptions relating to the impact of possible future uncertainties in global economic conditions because of this pandemic, the Company as at the date of approval of these financial results has used internal and external sources of information including economic forecasts. The Company based on current estimates expects that the carrying amount of the above assets will be recovered, net of provisions established. The Company has also assessed the impact of this whole situation on its Capital and Financial Resources, Profitability, Liquidity Position, Internal Financial Controls, etc. and is of the view that based on its present assessment, this situation does not materially impact these financial results. The impact assessment does not indicate any adverse impact on the ability of the Company to continue as a going concern. However, the impact assessment of CoVID-19 is a continuing process, given the uncertainties associated with its nature and duration. The Company will continue to monitor any material changes to future economic conditions.

(6) Exceptional Items: In respect of tax benefits due to adjustment of unabsorbed losses and depreciation of erstwhile TTK Protective Devices Limited and TSL Techno Services Limited which merged with the Company, with effect from 1st April, 2012, (shown as Contingent Asset in earlier years), the Company has received the revised assessment orders in the Quarter ended 30th September, 2020 and the refund received is accounted as follows:

(a) Rs.809.79 lakhs towards Intereston Tax Refund received is freated as Exceptional Income; and

Re 809 79 lakhe towards Interest on Tay Refund received is treated as Excentional Inc

(b) Balance Refund received (net of certain provisions considered necessary amounting to Rs.999.74 lakhs) of Rs.1,964.81 lakhs has been accounted

as Tax Refund relating to earlier years.

The Code of Social Security, 2020 ("Code") relating to employee benefits, during employment and post-employment, received Presidential assent on 2 September, 2020. 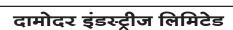
